Protect Your Account from Dormancy & Escheatment Fees

Please note that inactivity or failure to update your account information could result in any of the following fees:

- ★ Dormant account fee of \$25 per quarter will be assessed if the account has been inactive over the past 2 1/2 years.
- ★ Escheatment notice mailing fee of \$2 will be charged from your account to notify you at least 6 months prior to the potential escheatment.*
- ★ Returned mail fee of \$5 per piece will be assessed if any Sea Air FCU mailed correspondence is returned as undeliverable.

The following actions can help you avoid such fees:

- ★ **Update your address**
 - Download and mail in a completed "Change of Address" form
 - Send a secure message using online banking
- ★ **Intent to keep the account**
 - Mail in a signed hand-written letter
 - Send a secure message using online banking
- ★ **Visit our branch to update your information**
- ★ **Conduct a financial transaction**

*Financial institutions are required by law to escheat inactive accounts after the 3-year period to the State Controller's Office of Unclaimed Property.
